


Removal Instructions:

- 1. Disconnect the negative battery terminal.
- 2. Remove the intake tube and throttle cable.
- 3. Remove the OEM throttle body from the intake manifold.
- 4. Measure the resistance in the factory TPS by connecting an ohmmeter to terminals A and B as shown in Figure 1. Record this value as it will be used in installation.
- 5. Remove the factory IACV and TPS from the throttle body unit.



Installation Instructions:

- 1. Install the IACV spacer with the included gaskets using the two supplied M6 screws. Reinstall the factory IACV.
- 2. Install the factory TPS. Calibrate the TPS by rotating the sensor and measuring the resistance between terminals A and B as shown in Figure 1. Once the setting is the same as was recorded during removal, tighten the screws to secure the TPS.
- 3. Install the throttle body onto the intake manifold with the gasket and the supplied M8 screws.
- 4. Connect the intake tube and throttle cable.
- 5. Connect the negative battery terminal.
